The Year of 2020 Vision

2020 brought many unexpected challenges. At Prevent Blindness (PBO), we planned to make it “The Year of 2020 Vision” as a way to bring focus to our mission – to prevent blindness and preserve sight.

All that changed with the pandemic upon us.

Knowing that healthy vision is essential for healthy living, we quickly transformed our services for people in need to virtual formats. This includes our inventing a new approach to training child and adult vision screeners virtually. Our vision screeners served 264,044 last year!

PBO also matched 3,649 disadvantaged Ohioans who were at risk for vision loss with donated eye exams and eyeglasses via our web portal. This in-kind contribution from the vision industry has a retail benefit of nearly \$1.5 million.

Your support of Prevent Blindness makes it possible for us to have the solid foundation in place to continue our work to address the 50% of vision loss that is preventable! We were able to reach 1.1 million Ohioans last year, only because of our dedicated donors, volunteers and staff.

We thank you for joining us in our fight to protect the gift of sight for all. Through your continued support, we hope that we may someday see a time when preventable vision loss is eradicated.

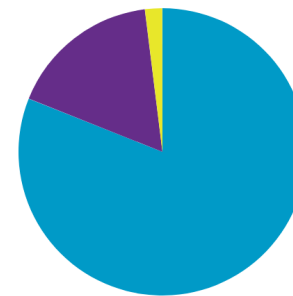

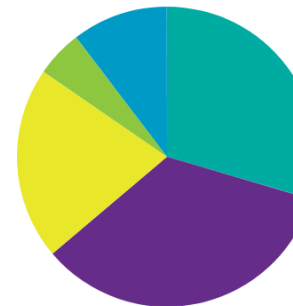

In December 2012 PBO began a partnership with the clinic to better serve their vision patients. "This partnership with PBO enabled patients to receive eyeglasses at no cost – eliminating the barrier to corrected vision, thus improving overall quality of life," said Carol Achmoody, Health Clinics Director for the Center.

Since beginning this partnership, VFHC has referred nearly 1,250 patients to PBO for eye exams and glasses via a seamless on-line application process.

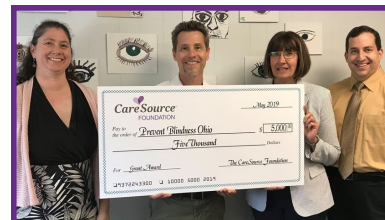
"Our patients are always grateful for their free eye exam. And we never tire of eyes

PBO trained, certified and equipped 989 children’s vision screeners last year. New screeners came from primary care practices, child care organizations and schools. PBO vision screeners served 233,720 children throughout Ohio. The Save Our Sight Fund is administered by the Ohio Department of Health, Bureau of Maternal, Child and Family Health.

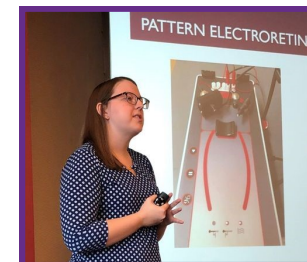
2019 Research Fellows Present Findings at Vision Forum

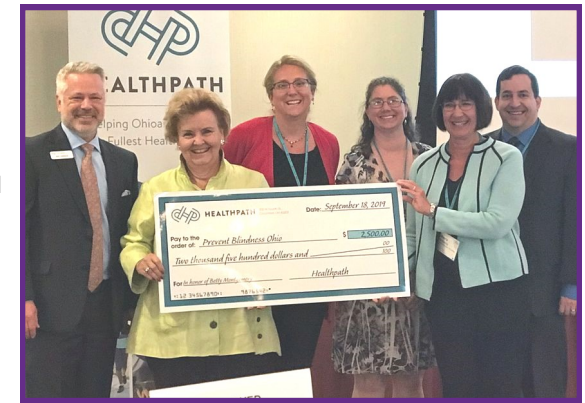
Hispanic Fund Provides for Community Services

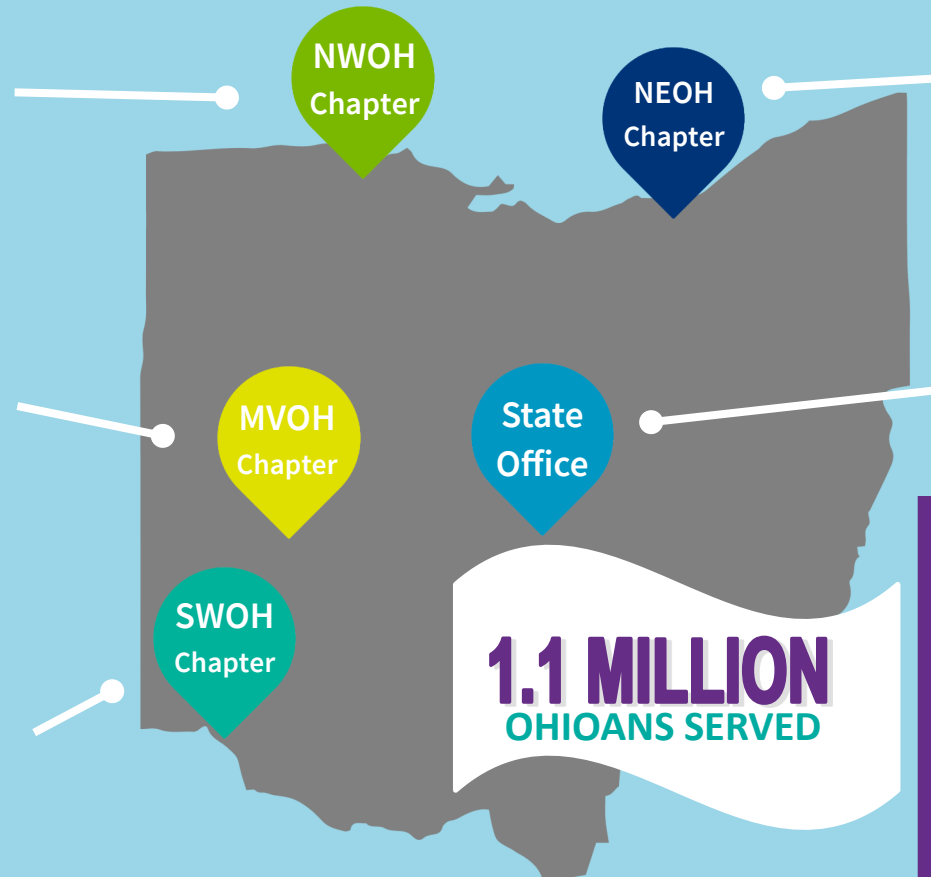

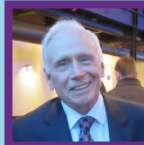
