### **2022 Research Fellows Present Findings at Virtual Vision Forum**

PBO's 2022 Young Investigator Student Fellowship Awards for Female Scholars in Vision Research were given to recipients Archana Murali from the Case Western Reserve University Ophthalmology Department, Erica Shelton from The Ohio State University College of Optometry, and Olivia Taylor from The Neuroscience Department at The Ohio State

Murali studied "Immunoblot Analysis of Lymphatic Marker Expression in Human Ciliary Body Cells Following Prostaglandin Analog Treatment;" Shelton studied "Assessing Social Determinants of Health in the Pediatric Population's Utilization of Vision Care Services Using Data from the National Survey of Children's Health;" and, Taylor studied "Exploring Sphingosine 1-Phosphate as a Mediator of Retinal Regeneration via Epigenetic Regulation of Muller Glia Reprogramming."

# Children's Vision Screening Expanded Through Grade 12

PBO expanded its Children's Vision Screening Training and Certification to reach children ranging from preschool through grade 12 (formerly through grade 1). The training course has been updated and all new screeners are trained in PBO's new workshops that are available as virtual (self-paced), live virtual, and in person. New equipment is available to screen the older age groups (grades 2 and beyond). Thanks to funding through the Save Our Sight Fund at the Ohio Department of Health, Prevent Blindness Ohio can provide this training and new equipment to certified screeners at no cost to them.

### A Message from our Leadership

#### A Return to Normal?

Our 2022-2023 fiscal year began emerging from the pandemic. Events and meetings were slowly moving from online platforms back to in person and sometimes hybrid formats. We quickly realized that we were not, in fact, returning to normal – we were moving forward and engaging in new ways.

How we work with our partners and our clients is forever changed. Our children's and adult vision screener training courses continue to be offered in three modalities, virtual (self-paced), live virtual, and in person. Trainees can choose the modality that works best for them. We reach far more trainees through our virtual trainings than in person. For three years running, we have the added bonus of offering school nurses Continuing Nurse Education credits for completing our children's vision screener training.

We have re-engaged and expanded our Vision Care Outreach Program (which provides donated eye exams and glasses for underinsured and uninsured Ohioans). During the year, we recruited and trained more than 25 new partner organizations and re-engaged with 30 more. We also updated the strategic plan for the Aging Eye Public Private Partnership and expanded the partnership's reach. These successes helped us expand our service reach and ensured that more Ohioans accessed the vision care services they needed to save their sight. Through our direct services, public education and advocacy, we reached more than 900,000 Ohioans of all ages.

Thank you to all our donors for your critical support – YOU make it possible for us to continue our work to address the 50% of vision loss that is preventable!



### World Sight Day 2022 is a Success

World Sight Day was October 13, 2022. Thanks to grant support from Horizon Therapeutics and Prevent Blindness America, Prevent Blindness Ohio celebrated and promoted good vision and eye health in the Governor Thomas Worthington Center at the Ohio Statehouse. PBO distributed World Sight Day information along with PBO eye health and safety information, and conducted adult vision screenings for legislators, legislative staff, executive staff and the general public.

Over thirty people attended, including multiple legislators, legislative staff, PBO Board members and the general public.

# **Partner Organization Spotlight**

PBO works with partner organizations throughout Ohio so they can offer valuable eye care service to their clients.

One such partner is Physicians CareConnection (PCC), an affiliate of the Columbus Medical Association and a volunteerbased, charitable organization that helps coordinate care for adults in Central Ohio who have

healthcare challenges due to individual barriers. Many do not know the importance of caring for their vision.

PCC Care Coordinator, Kouzan Abdullah calls PBO a "gem in town" as hundreds of their clients have benefitted from PBO services. When clients come to PCC for various health issues, the staff also asks them when they last had an eye exam. Most either don't recall because it has been so long, or they never have had one at all. "Many of our clients do not know the correlation between their health and their eyesight," explains Abdullah. "We enroll them with PBO and get them a voucher for an eye exam and glasses, if needed." She added, "Being able to help clients with wraparound services with the help of PBO has been amazing."

### **Aging Eye Summit Brings Together Aging Eye Experts**

The Aging Eye Summit took place on June 23, 2022 at The Ohio State University Faculty Club, as well as virtually. The hybrid Summit was a great success with 75 individuals participating virtually and another 44 participating in person.

The Summit featured a lineup of experts speaking on a variety of topics including: aging eye diseases, with a focus on current research and

treatment for glaucoma; disparities in vision healthcare; using health surveillance data to assess barriers to vision care in Ohio; technology and low vision management; and uveitis, a clinical discussion and patient perspective.

# **PBO Offers CNE Units for Nurses**

PBO is pleased to offer licensed nurses, including school nurses, 4 Continuing Nursing Education (CNE) Units for becoming a Prevent Blindness Certified Children's Vision Screener. Since the program's inception in the Fall of 2020, 610 nurses have earned these CNEs.



PBO provides the activity in conjunction with Ashland University, Dwight Schar College of Nursing and Health Sciences.

Licensed nurses who complete all components of this training may obtain 4.0 credits of continuing nursing education.

The Prevent Blindness Certified Children's Vision Screener Training program is paid for in part by the Save Our Sight Grant through the Ohio Department of Health.

# **Save Our Sight and Ohio Drivers Fund Children's Vision Screenings**

Prevent Blindness Ohio received a grant in the amount of \$475,000 for the period July 1, 2022 through June 30, 2023 from the Ohio Department of Saveour Sight™ Health Save Our Sight (SOS) Fund for PBO to train and certify 700 children's vision screeners at schools, primary healthcare practices and public/private child care organizations. The funding comes from Ohioans who donate \$1 or more to SOS when they renew their Ohio motor vehicle registrations.

This funding also allows PBO to provide vision screening equipment to children's vision screeners at no cost to them.





# **PBO Introduces Refresh & Recertify Class**

PBO introduced a new Refresh & Recertify training opportunity for individuals already certified as adult vision screeners, but who need to renew their certification and/or refresh their adult vision

screening skills.

Adult vision screening certification is good for three years and, in the past, after certification has expired, the recertification test could be taken online to renew the threeyear certification. However, often trainees would have



questions and would want to retake the training to refresh their skills. The program was created for those interested in getting a refresher course without having to retake the full training.

Without insurance or the financial resources to get their children glasses, the family was referred to the PBO Vision Care Outreach Program for free eyeglasses. The brothers wrote to us...
