Qualifications: A minimum of a bachelor's degree in a public health or healthcare administration related field (Master's preferred). Desired experience includes:

- At least 2 years' experience in the healthcare administration/education and/or public health systems and in building collaborative public health service systems
- Must have the ability to self-start, lead, work successfully with diverse stakeholders, provide empathy, research and build partnerships, and to think systemically and strategically
- Needs to demonstrate a commitment to the systems approach to public health and empowering individuals and communities to better their health and well-being
- Additional experience in vision and eye health from a public health perspective is preferred, but not essential

Reports to: Vice President of Programs & Government Affairs

Responsibilities: Work in partnership with the President & CEO and the VP of Programs & Government Affairs to:

- Seek and implement public health research projects related to the study of best practices in population health related to vision care
- Secure potential partners within the public health arena, such as county or state departments of health, and other community service organizations to add vision health to their service offerings
- Secure potential partners within the community health sector, such as Federally Qualified Health Centers, Community Health Centers, Primary Healthcare Facilities, and other health care organizations, to add vision health services to their care practices
- Provide technical assistance to partners to promote system integration of vision and eye health into their care practices
- Recruit and develop high-level relationships with community partners that refer clients to the Vision Care Outreach program
- Produce documents that promote the addition of vision related health care into public health and community health care settings
- Assist in the drafting of proposals and project updates for grants that support the work of the program areas of responsibility
